Competition rules

Draw organised by LISER in the presence of a bailiff

- The Luxembourg Institute of Socio-Economic Research, hereinafter referred to as "LISER" or "Centre", established at Maison des Sciences Humaines 11, Porte des Sciences, L-4366 Esch-sur-Alzette/Belval, represented by its statutory bodies currently in office, is organising a competition relating to the "FragMent Study" (hereinafter referred to as the "Study").
- 2. Participation in the competition begins on 28 October 2024 and ends on 30 September 2025.
- 3. The competition is open to individuals (hereinafter referred to as 'participants') who have consented to take part in the Study and meet the following conditions: be eligible for the Study, complete the two FragMent questionnaires this is referred to as partial participation and have reached the end of the 15-day mobile survey this is referred to as full participation.
- 4. Staff members (salaried and self-employed) of the Centre organising the competition, as well as family members of the above-mentioned persons, may not take part in this competition.
- 5. 96 Amazon vouchers on the German site worth EUR 100 are up for grabs for a full participation, 48 Amazon vouchers on the German site worth EUR 50 are up for grabs for a partial participation.
- 6. 4 draws will be held by a bailiff
 - 1 between the 1st and the 15th January 2025, for participants between 28th October and 31st December 2024
 - 1 between the 1st and 15th April 2025, for participants between 1st January and 31st March 2025
 - 1 between the 1st and 15th July 2025, for participants between 1st April and 30th June 2025
 - 1 between the 1st and 15th October 2025, for participants between 1st July and 30th September 2025

For each draw, 24 participants in the full study and 12 participants in the partial study will be drawn at random and declared winners. The winners of the competition will be notified and will receive their prize by email.

- 11. LISER undertakes to comply with current data protection regulations.
 - LISER collects identification data on the basis of participants' consent for the purposes of registering and managing lottery participants.
 - LISER undertakes to use personal data solely for the purposes for which it was collected and to keep it confidential. No personal data is passed on to third party organisations.
 - LISER undertakes to facilitate the exercise of the rights of the persons concerned by the means communicated to the participant for this purpose.
 - All data collected for the purposes of this competition will be destroyed by LISER at the close of the lottery.
